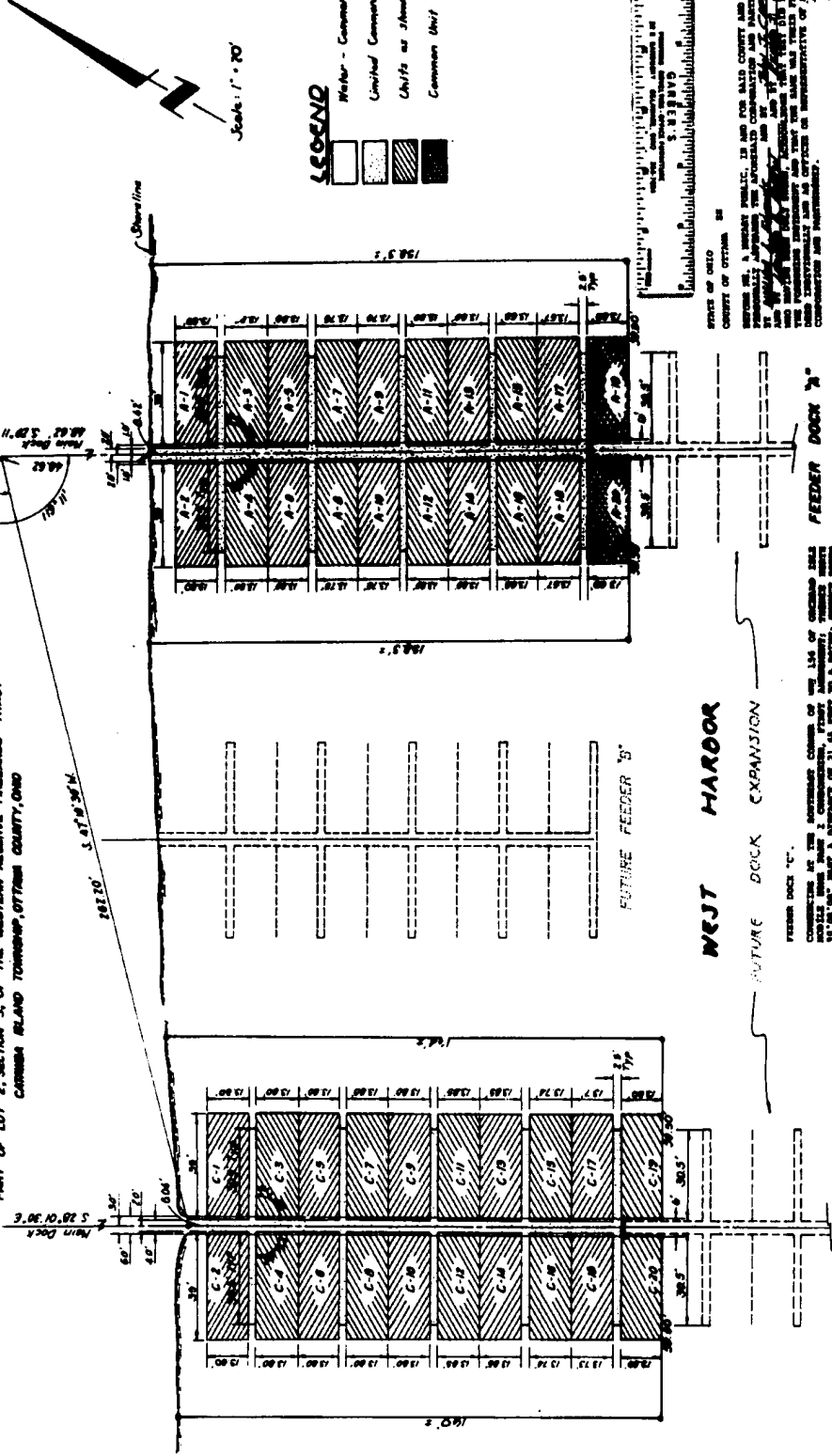


SECOND AMENDMENT

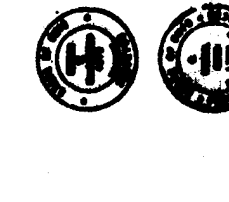
