IN THE MATTER OF AGREEMENT FOR REGIONAL
SEWERAGE PLAN FOR LUCAS COUNTY, OTTAWA COUNTY,
WOOD COUNTY AND THE CITY OF OREGON, OHIO

It was moved by Mr. Milbrodt and seconded by Mrs. Rofkar, that the following agreement be entered into between the City of Oregon, Ohio and the Board of Ottawa County Commissioners:

AGREEMENT FOR REGIONAL SEWERAGE PLAN FOR LUCAS COUNTY,
OTTAWA COUNTY, WOOD COUNTY AND THE CITY OF OREGON, OHIO

Whereas, it is the intention of the City of Oregon to construct a wastewater treatment plant and collection system and the City is willing to make this system and plant available to other subdivisions and

Whereas, Lucas County, Ottawa County and Wood County and their individual subdivisions can in the future make use of this regional system and

Whereas the areas and limits of this regional system should be defined it is resolved as follows:

Resolved that

1. The City of Oregon offers its plant and collection system to the various counties for a regional sewerage system, and agrees to accept their waste and provide the required treatment thereof, all in accordance with rules and regulations that will be established for the collection and treatment of wastewater.

2. And, whereas the counties of Lucas, Ottawa and Wood must in the future construct sanitary sewer systems and will need adequate treatment for the waste collected. They agree to utilize the regional system offered by the City of Oregon providing that equitable rates for sewerage service are determined at that time.

3. It is understood that until such time as the need is dictated in the various counties for a regional system, that the counties will continue to maintain their interim wastewater
