**Commencing** Point of Beginning - In Northeast Quarter, Section 18, Salem Township, at or near 12" crossover under T. R. #111, Portage South Rd.

Point of Termination - 36" pipe along West side S.R. #19, just south of Elden Leow's barn.

Total distance being 1.37 miles more or less.
