Petition to ¹ **reconstruct a branch of the Dwelle Ditch**

To the Board of County Commissioners **Ottawa** County, Ohio:
Commissioners, Engineer,

The undersigned hereby petition your honorable body to ¹

reconstruct a branch of the Dwelle Ditch

on the course hereinafter set forth.

The construction of the improvement is necessary, and will be conducive to the public welfare.

The following is the course and termini of said proposed improvement, to-wit:

Commencing on the east side of the corrugated pipe culvert under the Gypsum Road # 33. Said pipe culvert being at the south line of Gypsum approximately on the south line of Section 2 in Portage Township; thence in an easterly direction approximately on said section line to the Dwelle Ditch or to a sufficient outlet.

Being in all a distance of approximately .4 of a mile.

The following is the nature of the work petitioned for:

reconstruction of a branch of the Dwelle Ditch
