

Petition to ¹ locate and construct a storm sewer, together with catch basins,

To the Board of County Commissioners County, Ohio:
Commissioners, Engineer,

The undersigned hereby petition your honorable body to ¹ locate and construct
a storm sewer, together with catch basins

on the course hereinafter set forth.

The construction of the improvement is necessary, and will be conducive to the public welfare.

The following is the course and termini of said proposed improvement, to-wit:

Commencing

1. A 12" storm sewer on the south side of Elmwood Parkway Street, commencing at the northeast corner of lot number fifty-nine (59), Elmwood Park Addition, and ending at the northwest corner of Lot number seven (7), Elmwood Park Addition, together with three catch basins located at the west ends of lots number fifty-nine (59), thirty-three (33) and seven (7), Elmwood Park Addition.
2. A storm sewer commencing at the southwest corner of lot number twenty-seven (27), Elmwood Park Addition, and thence along the west lines of lots number twenty-seven (27) thru thirty-three (33) inclusive, being 12" in diameter, thence continuing north across Elmwood Parkway and becoming a 14" storm sewer at the southwest corner of lot number thirty-four (34), Elmwood Park Addition, and thence continuing north as a 14" storm sewer along the west lines of lot number thirty-four (34) thru thirty-nine (39), inclusive, all in Elmwood Park Addition, Section twenty-eight (28), Clay Township, Ottawa County, Ohio.
3. The following catch basins:
 - One each at the south end of Thyre Drive and south end of Smith Drive, one to be located on the west side of Thyre Drive approximately in the middle of lot number thirty (30), Elmwood Park Addition, and one to be located on the west side of Smith Drive approximately in the middle of lot number seventeen, Elmwood Park Addition.
 - One located on the west side of Thyre Drive approximately on the north line of Lot number thirty-five (35), Elmwood Park Addition;
 - One located on the east side of Smith Drive approximately on the north line of Lot number twenty-two (22) Elmwood Park Addition;

The following is the nature of the work petitioned for:

- One located on the north end of Thyre Drive.
- One located on the south side of Elmwood Parkway, 100 ft. East of Boundary Drive
- One located in the Northeast corner of Lot number Fouty Six (46)

The following is the nature of the work petitioned for: location and construction of a storm sewer, together with catch basins.
