The undersigned hereby petition your honorable body to <sup>1</sup> reconstruct Kempke Rd. #60 Ditch, aka Schott Ditch, by possible deepening and widening.  
on the course hereinafter set forth.

The construction of the improvement is necessary, and will be conducive to the public welfare.

The following is the course and termini of said proposed improvement, to-wit:

Commencing at the southeast corner of the intersection of Elliston-Trowbridge Rd. #208 and Kempke Rd. #60 at the outlet end of the existing 48 inch reinforced concrete pipe culvert in Section 5, Town 6 North, Range 14 East, in Harris Township and thence east along the south side of said Kempke Road approximately 2650 feet to LaGarpe Creek and terminate at the 72 inch reinforced concrete pipe culvert under said Kempke Road.
