To the Board of County Commissioners Ottawa County, Ohio:
Commissioners, Engineer,

The undersigned hereby petition your honorable body to ¹
reconstruct by deepening and possible widening

on the course hereinafter set forth.

The construction of the improvement is necessary, and will be conducive to the public welfare.

The following is the course and termini of said proposed improvement, to-wit:

Commencing at the north end of the crossover pipe under S.R. #163 in the southwest quarter of Section 34 in Benton Township; thence east through Sections 34, 35 and 36 of Benton Township to the Benton-Carroll Rd #23 or to a sufficient outlet.

the total length of this project is approximately 3½ miles.

Reconstruct by deepening and possible widening.
