Petition to ¹ relocate and tile a ditch along the west side of the Linker-Portage Road #46

To the Board of County Commissioners
Commissioners, Engineer,

Ottawa County, Ohio:

The undersigned hereby petition your honorable body to ¹

relocate and tile a ditch along the west side of the Linker-Portage Road #46.
on the course hereinafter set forth.

The construction of the improvement is necessary, and will be conducive to the public welfare.

The following is the course and termini of said proposed improvement, to-wit:

Commencing on the west side of the Linker-Portage Road #46 at a point approximately 200 feet south of the Elmore East Road where a culvert crosses under the Linker Portage Road; thence north on the west side of said Linker Portage Road crossing under the Elmore East Road and continuing north on the west side of Linker Portage Road as near as possible to the edge of the present bituminous macadam pavement to a point near the south line extended of Winkle Road #84; thence in a northeasterly direction crossing Linker portage Road to a point on the north side of said Winkle Road; thence north along the east side of Linker Portage Road and crossing Smith Road # 151 to sugar Creek and there to terminate.

Being in all a distance of 2200 feet.

The following is the nature of the work petitioned for:

Construction of a catch basin at the beginning of the project and layin a 15 inch pipe from said catch basin north along the Linker Portage Road and continuing with said 15" pipe to the outlet in Sugar Creek as outlined in above description. Said 15" pipe to be placed at sufficient depth to adequately drain the present tile draining from the fields west.
