The undersigned hereby petition your honorable body to <sup>1</sup> **reconstruct by deepening and widening of the Richard's Branch of Turtle Creek.**  
on the course hereinafter set forth.

The construction of the improvement is necessary, and will be conducive to the public welfare.

The following is the course and termini of said proposed improvement, to-wit:

**Commencing** for the upper terminous in the lands of Harry Miller and the Northeast quarter of Section 32, Township 7 North, Range 13 East in Clay Township and running thence in an Easterly & Northeasterly direction, through Sections 32, 33, 28, 21 and 22 to a point where the Bloomfield Branch of Turtle Creek joins the Richard's Branch, or to a sufficient outlet to be determined by the Engineer in the course of his survey and there to terminate. Total distance being approximately four (4) Miles.
