Road from 100 yards east of the intersection of State Rt. #51  
to Reiman Road then south to where it is sewerred.

The undersigned hereby petition your honorable body to <sup>1</sup>  
reconstruction of ditch by deepening.

on the course hereinafter set forth.

The construction of the improvement is necessary, and will be conducive to the public  
welfare.

The following is the course and termini of said proposed improvement, to-wit:

Commencing

at approximately 100 yards east of intersection of State Route  
#51 and Moline-Martin Road #66 on the south side of the Moline  
Martin Road, then east to the Reiman Road #53, then south on  
the west side of the Reiman Road #53 to where the ditch is  
sewerred and there to terminate. Note-Ditch is sewerred app.  
1 tenth of a mile before entering the South Branch of Turtle  
Creek.
