on the course hereinafter set forth.

The construction of the improvement is necessary, and will be conducive to the public  
welfare.

The following is the course and termini of said proposed improvement, to-wit:

Commencing on the Clarence & Myrtle Bahnsen property in Lot <sup>9</sup>19, Sec. 4, Danbury  
Township approx. 1000 ft. West of S.R. 240, thence southerly through Lots 9 & 15  
under the Port Clinton Eastern Road #5 to the main Schmardebeck Ditch at old  
Sta. 91 + 50, thence westerly and southerly under old S.R. #2, new S.R. #2 and  
N.Y.C.R.R. to the Sandusky Bay at old Sta. 149 + 90. Total distance being  
approximately 1.9 miles.
